December 2020 P&L (See attached.)

Board reviewed annual operating budget. We had a strong year despite the pandemic. Class revenue was higher than budget. We also received PPP money (\$21,000) for support during the last year. We also received more revenue from retreats than what was budgeted. We are over by 112% over budget. We also reviewed our balance sheet. We have about 2/3 of our pledges to capital budget in. Historically, we have good results in getting in pledges. A request was made to make a Statement of financial position report quarterly now we are taking on additional debt.

Budget for 2021

Increases in expenses most notably repayment of construction loan with additions to DEIA, guest teachers, insurance.

Budget discussion will finish next month.

Provisional approval given to move budget forward. Karen moved. Randy 2<sup>nd</sup>. Approved.
